### Overview

- Liaising with clients to understand and feedback technical requirements.
- Preparation of technical reports and produce data for delivery within stated deadlines to a high standard.

- Managing and maintaining Quality, Environment and Health and Safety standards including updating, implementing and management of all ISO processes as appropriate to the role.
